

# Privacy Policy

This Privacy Policy ("Policy") applies to thereynapp.com, and Style Made Easy, LLC ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include thereynapp.com. The Company's website is a fashion media site. By using the Company website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

- First and last name
- Email address

### **Sharing Information with Third Parties**
